# MIDLOTHIAN PUBLIC LIBRARY BOARD TRUSTEES MEETING October 18, 2016

The meeting was called to order by President Becker at 7:00 p.m. Present were Trustee Baker, Trustee Ceja, Trustee Ferguson, Trustee Gray, Trustee McDermott, , and Christy Parente, Recorder of Minutes. Trustee Chiz and Director McCammond-Watts were absent.

# **MINUTES**

On a motion by Trustee Baker and seconded by Trustee Gray the minutes of the September 20, 2016 meeting were approved by roll call vote. 5 ayes and 0 nays. Trustee Ferguson abstained because she was not present at the September 20, 2016 board meeting.

# REVIEW OF BILLS AND FINANCIAL ACCOUNTING

On a motion by Trustee Gray and seconded by Trustee Ferguson the financial report for September 2016 was reviewed. Total cash balance for the building account was \$94,647.71, for the reserve fund \$277.05, for the real estate fund \$678,858.79 and \$908,343.95 for the money market account. The financial report was unanimously approved by roll call vote. 6 ayes and 0 nays.

A motion to pay all October bills in the total amount of \$38,966.07 was made by Trustee Gray and seconded by Trustee Baker and unanimously approved by roll call vote. 6 ayes and 0 nays.

# **NEW BUSINESS**

- A. Long Range Plan Review Trustee Baker reviewed the committee meeting from Oct 14. The committee reviewed the 32 patron responses. Some common themes were: customer service, new technology, extended hours and a need to advertise upcoming programs more efficiently to the patrons. Patrons are becoming nomadic and the library need to stay current to keep our patrons coming to their home library. Some patrons are still looking for traditional services and noise is a concern. The committee is finished with the discovery phase and will be moving into the dream phase of getting goals on paper. The committee will meet again in Nov.
- **B.** Records Retention Ms. McCammond-Watts is looking into getting approval from the state to purge some of the library's older records. Once the state gives the library approval they will tell us how often and which records can be purged.
- C. Amended Budget and Appropriation FY 17-18 The amended appropriation will be changed from \$1,221,405.00 to \$1,259,228.00. A motion to accept the Amended Budget and Appropriation for FY 2017-2018 was made by Trustee Baker and seconded by Trustee McDermott and unanimously approved by roll call vote. 6 ayes and 0 nays.

Trustee McDermott questioned the patron surveys that sited the lack of materials that were available and if this is due the recent weeding project or the selection of new materials not reflecting what the community wants.
